



TERMS OF RENTAL AND USE - BIKE

1) Acceptance

- a) Before using the bike, the renter/participant must familiarize themselves with how the bike works.
- b) The renter/participant is obliged to check the bike for road safety, functionality, and defects before starting the ride. If there is a technical defect at the start of use that could obviously affect road safety, the renter/participant must immediately inform the rental company and stop using the bike immediately.

2) Use

- c) The renter must be at least 18 years old when renting. Minors (under 18 years old) may only take part in tours after consultation with the guide and with the consent of their legal guardian.
- d) The renter/participant is obliged to observe the rules of the road traffic regulations.
- e) Helmets are generally compulsory. Helmets are available when booking and are included in the rental price. On tours led by MAINPEAK, there is also an obligation to wear sturdy shoes.
- f) For tours led by MAINPEAK, the participant must assess for themselves before starting whether the tour is appropriate for their health and fitness level and riding ability.
- g) The instructions of MAINPEAK employees must always be followed.

3) Return

- h) The renter/participant is obliged to return the vehicle to the lessor at the end of the rental period specified in the rental agreement at the location specified in the rental agreement during opening hours. The vehicle and all accessories provided by the lessor must be returned in perfect condition. Loss or damage will be charged to the renter/participant.
- i) An extension of the rental agreement is only possible with the consent of the lessor. The lessor can refuse an extension without giving reasons.

4) Liability

- j) The renter/participant undertakes to use the rented items properly and carefully. The bicycle must always be attached to fixed objects, even if it is parked for a short time. The renter/participant is responsible for any damage caused by negligence or improper use. Riding on paths not approved for bicycle traffic is prohibited. In the event of accidental damage, loss, theft or improper handling, the renter/participant is liable for the cost of repairs or replacement value. In the event of personal injury, the renter/participant is liable.
- k) Participation in tours and bike rental is at your own risk. The organizer's liability is limited to intent and gross negligence.

5) Cancellation

- l) Payment is made before the start of the rental period or the booked tour.
- m) The renter/participant can cancel their reservation free of charge up to 3 days / 72 hours before the start of the rental. In the event of later cancellation or no-show, 100% of the fee is due.

6) Applicable law and place of jurisdiction

- n) The contract is subject to Portuguese law. The court at the location of the lessor has exclusive jurisdiction.
